

In the State of New Mexico, the employer/insurer has the right to direct medical care. Under §52-1-49, the employer/insurer must decide whether to choose the initial health care provider or to allow the worker to choose the initial health care provider. The party who makes the initial selection retains the right to continue with that doctor for the initial 60 days, after which time the other party must file a change in writing if they want to redirect the health care under the Automatic Right of Second Selection. The forms are available at the local Workers' Compensation Administration office or by calling toll-free 1-800-255-7965. In this case, the employer/insurer has chosen to direct you to one of the providers listed below. Please call the Health Care Provider for an appointment. The provider you select should contact Selective, or its adjusters, for all authorizations, approvals and billing questions.
